### Sustaining Membership Rules

- Sustaining Membership dues are \$500 per membership year, beginning on July 1 through June 30. If application for Sustaining Membership is submitted in the months of May, June, or July dues will be the full \$500. If application for Sustaining Membership is submitted in any other month, dues will be prorated for the balance of the months remaining the membership year. All applications must be accompanied with payment for the applicable amount.
- Sustaining Membership is available to a GADA member whose franchise agreement with a manufacturer of new motor vehicles was terminated, voluntarily or involuntarily, provided such member's GADA dues were current as of the date of termination and that such member continues to be actively engaged in the business of selling used vehicles. Sustaining members shall not be eligible to vote or to serve as members of the Board of the Association or its affiliates or subsidiaries. All memberships are subject to the approval of the GADA Board of Directors or its designee(s).
- According to IRS rules, GADA dues are partially deductible as an ordinary business expense. Each year you will be notified of the percentage that is deductible. Contributions or gifts to Georgia Automobile Dealers Association are not deductible as charitable contributions for federal income tax purposes.
