- Late last week, Governor Kemp issued a new Executive Order effective June 1, 2020. TAG & TITLE INFORMATION

- The Georgia Department of Revenue (GADOR) issued an extension of tag and registration deadlines until June 15. [View details here](#)
- GADOR has made available a DRIVES e-Service that allows customers to pay for and order a tag online. This can be used when dealers perform title only transactions via ETR. [View Message from GADOR](#)
- Note that GADOR's extension of registrations and temporary tags does not extend the time period in which dealers must submit title applications. For purposes of timely lien perfection and remittance of TAVT, dealers must continue to submit title applications within 30 days of transaction.
